#### **Citizen Patrol History**

Citizen Patrols or similarly named programs have been in existence for many years. During WWII, the nation lost many of its police officers due to being drafted into military service. This gap was filled with some of the first Citizen Patrols who augmented law enforcement agencies. Our agency's Citizen Patrol began in 2010 with the main purpose of deterring car break-ins in the Columbia River Gorge. In 2019, the Citizen Patrol partnered with the City of Fairview to patrol their area parks. Members of the Citizen Patrol act as extra "eyes and ears" for law enforcement. Since the Unit's inception, Citizen Patrol volunteers have repeatedly provided patrol deputies with information that have led to the arrest of various suspects.

#### **The Mission**

The mission of the Citizen Patrol program is to help reduce crime and the fear of crime. This is accomplished by providing a visible presence as a deterrent to criminal activity. Citizen Patrollers work in the Columbia River Gorge National Scenic Area, the Corbett community and within the City of Fairview. Secondary missions include supporting Law Enforcement and Fire personnel during natural disasters or other emergencies and assisting at community events such as the National Night Out.

#### **Member Requirements**

- 1. Be at least 21 years of age
- 2. The ability to drive the Citizen Patrol car during patrols
- 3. Have access to e-mail and a cell phone
- 4. Have a valid Oregon or Washington driver's license
- 5. No prior felony convictions
- 6. Volunteer a minimum of 6-hours per month

### **Application Process**

- 1. Complete an application and screening process
- 2. Pass a background check
- 3. Successfully pass the initial training

#### **How Patrols Operate**

Members always work with a partner during their patrols. Members choose when to volunteer based upon their own availability. Monthly trainings are offered on topics ranging from disaster preparedness to "Confrontational Simulation" scenarios. Members may choose which trainings they attend and when they patrol, however a minimum of 6-hours per month is required.

The Citizen Patrol unit works closely with the Multnomah County Sheriff's Office and the Multnomah County Office of Emergency Management. The Citizen Patrol has their own VHF radio repeater and numerous "Go-Radios" for quick mobilization and communications support during a disaster or other emergency. Members are trained in Incident Command System protocols and have the ability to selfdeploy in the event that phone communications are inoperable.
